(File Photo) SAN FRANCISCO — Homelessness is the number one human rights issue for people experiencing homelessness in the San Francisco Bay Area, according to the Human Rights Commission. “It’s also the most urgent,” said Sam Singer, Executive Director of the commission. “We have a long way to go before homelessness is eliminated in California.” On Wednesday night, at the 75th annual Golden Gate Parade in San Francisco, a first-time winner will be crowned for best theme. A panel of Golden Gate Human Rights Commission members will review and vote on nearly 600 Parade entries through a formal review process. In this year’s competition, the theme is “Choose a Side.” The Golden Gate Human Rights Commission was created by and is funded by the United Way of the Bay Area. This is the first time the commission has submitted a theme to the Golden Gate Parade and is the first time a Grand Marshal has won in the past seven years. Winners of the second annual theme week event will be announced at the January 5 parade. Winning Parade entries will be posted on the Golden Gate Human Rights Commission’s website and its social media pages. The theme is chosen for its relevance to the human rights movement in the United States and in California, which — along with several other states — has the strictest laws prohibiting discrimination against LGBT residents. Currently, 49 percent of LGBT homeless youth are housed in the shelter system, compared to 36 percent of all youth, according to a study done by the National Center on Homelessness among Veterans.
