The launch of the new pharmacopoeia by Dr Rajendra Prasad, the first President of India, has strengthened the international dimension of the Indian pharmaceutical industry. This publication includes detailed monographs, classifications and lists of all the substances & articles listed in the Pharmacopoeia including pharmaceutical preparations, chemicals, substances and articles for use in pharmacy, microbiological agents, miscellaneous substances, articles and preparations. The pharmacopoeia covers the whole area of medicines including those which are not covered by other pharmacopoeia of the World Health Organisation (29), for example, nutritional and medicinal preparations.

This edition was released in August 1992. The aim of the edition is to provide a guide for the use of the pharmacopoeia. This edition has nine chapters. The chapters include analytical, preparation, pharmaceutical dosage forms, plant drugs, pharmaceutical products, drugs and other substances for human and veterinary use, substances for medical use, substances used as colouring agents. The first edition of Indian Pharmacopoeia was published in February 1974. The aim of the edition is to bring consistency in the definition of the substances, quality assurance, quality control, technical review, standardisation, and arrangement of the data. Similarly the edition is in continuation to the Malay Pharmaceutical Standards 1989. This edition has 30 sections, which include descriptions of raw drugs and drugs, description of preparations, pharmaceutical dosage forms, pharmaceutical products, preparations for external use, regional preparations and bath preparations, topical, ophthalmic and perineal preparations, local anaesthetics, pharmaceutical preparations, injections, vaccines, and medicinal products. A list of doctors required in Indian regulations to undertake national surveillance, any substance or combination of substances, controlled and noncontrolled substances, new and old drugs and dosage forms, and correspondence relevant to

the sections has also been provided in this edition. The drug marketing regulation has been added. In section 104 (Drug product subject to licensing) the substances that require licensing has been included. To date, a number of pharmacoepidemiologic studies have shown that exposure to hypnotic agents is not related with cancer risk. This means that an association between hypnotics and cancer has not been proven, but investigators should scrutinize this relationship more carefully. 5ec8ef588b
