If the defendant was present when the plaintiff fell, there was no proof that the condition which caused the fall was due to the defendant's negligence. The judgment dismissing the plaintiff's action for damages on a verdict of no cause of action cannot be said to have been based upon findings of fact supported by substantial evidence. [5] The second issue raised in the defendant's motion for a new trial was that the verdict was not supported by the evidence. In support of this contention the defendant argues that the evidence showed that the plaintiff was guilty of contributory negligence as a matter of law. The evidence was sufficient to show that the plaintiff started to move a load which was being lifted by a truck by attaching one end of the load to a hook which was placed on the truck. The witness Hughes testified that he saw the plaintiff doing this. The plaintiff testified that he looked up and saw the truck. He testified that he was going to pick up a *647 load of clean boxes. The witness Hughes testified that the plaintiff was about 30 to 35 feet from the truck when he started to lift the load. The plaintiff testified that he lifted the load by means of the hook which had been placed on the truck, which he "dropped" and when he was about seven or eight feet from the truck, he let go of the load and it fell on him. He testified that he thought the truck was about 45 feet from him at the time he started to lift the load. The jury was justified in believing the plaintiff and in rejecting the testimony of the defendant's witnesses that the plaintiff had been several feet from the truck when the load was dropped. [6] The final issue raised by the defendant in his motion for a new trial is that the trial court erred in admitting in evidence a certain photograph of the scene of the accident. This photo showed the place where the plaintiff fell and was taken some time after the accident occurred. The defendant contends that this photo tended to prove the plaintiff's own negligence in that he started to lift the load before the truck moved and that he should have known that the load would fall if he did this. The trial judge admitted the photo in evidence and the jury was entitled to consider it as evidence on the issue of contributory negligence. The admissibility of photographs is based on their
